Description

Legends Arena is undergoing a retrofit to repurpose the now decommissioned Centennial Arena ice rink into a multi court sports facility.

The arena is being divided into five (5) sections on the ground floor. The entrance will serve as the first section with approximate dimensions 35' x 120'. The next section comprises a volleyball court with the next two sections being configured for basketball. The courts will run perpendicular to the entrance with approximate dimensions of 57' x 120' each. The two basketball sections together can also serve as combined space with overall approximate dimensions of 114' x 120'. The front exterior of the building is undergoing a refresh.

RFQ Scope

This RFQ invites companies to provide current pricing and availability for PVC Wall Panels – Truss Core or equivalent. The following details are estimated and actual square footage may vary. The successful vendor will be expected to provide pricing and delivery information for an initial order. As well, the vendor may be called upon to supply additional quantities as the project progresses. Ordering will take place with an initial order followed by a second order. A possible final adjustment order may also occur.

Please indicate if the returning of material is an available. Product samples are welcomed.

All wall paneling will be fastened horizontally and gray in colour unless otherwise specified.

The successful Bidder shall protect Legends' property and other property on or adjacent to Legends' property from damage and shall be liable to Legends for any loss of, or damage to, the property to the extent such loss or damage arises or results from, directly or indirectly, the successful Bidder's performance of his obligations under the Contract or by reason of any matter or thing done, permitted or omitted to be done by the Contractor, the employees, servants or agents whether occasioned by negligence or otherwise. This liability shall survive the termination of the Contract.
2. Legends may direct the successful Bidder to rectify and make good any defect or fault which is not in compliance with the Contract Documents within 24 hours of such direction

If the successful Bidder fails to comply with any direction given by Legends in accordance with the Contract Documents, Legends may, at its sole discretion, cancel this contract as of the date of its direction.

Indemnification

The successful Bidder undertakes to indemnify and hold harmless Legends and its agents from and against all claims, demands, losses, costs, damages, actions, suits, or proceedings by third parties that arise out of, or are attributable to, their performance of the contract. This indemnity shall survive termination of the RFQ.
